

Ukrainian President: country will be represented at highest level at world exhibition Expo in Dubai



Ukraine will participate in the world exhibition Expo-2020 in Dubai and will be represented at a high level, Ukrainian President Volodymyr Zelensky said in an interview with the Emirates News Agency WAM.

"We simply cannot miss such an important world event as Expo 2020. I would like to thank the UAE leadership for the fact that, despite all the difficulties associated with COVID-19, the construction of the Ukrainian pavilion was completed in December last year, and internal work is underway there. At the World Expo in Dubai, our country will be represented at the highest level," Zelensky said in an interview with the Emirates News Agency WAM, published on the website of the President's Office of Ukraine on Saturday.

Zelensky noted that the architectural image of the pavilion of Ukraine embodies the idea of an ear of wheat, which will be 15 meters high.

"Wheat is an important symbol for Ukrainians, and the yellow color on our flag symbolizes the wheat field and readiness to contribute to world food security," the president of Ukraine stressed.

Ukraine plans to vaccinate against coronavirus up to half of population

Ukraine intends to vaccinate up to half of the population against COVID-19 this year and early next year, President Volodymyr Zelensky has said.

"We now identify the next priority in the fight against coronavirus – vaccination. Its roadmap is designed to ensure proper and equal access to the vaccine for all residents of Ukraine. Its main task is to cover at least half of Ukraine's population during 2021 and early 2022," Zelensky said at the opening of the "Ukraine 30. Coronavirus: Challenges and Responses" Forum.

He said that vaccines against COVID-19 from four companies will be delivered to Ukraine.

"We have agreed to supply the vaccine from the Pfizer, Sinovac, AstraZeneca and Novavax companies to Ukraine. The first stage of vaccination will begin this month. Our doctors, the military and the National Guard will be the first to receive the vaccine," Zelensky said.

In addition, the president said that Ukraine has taken the smart and effective steps to counter the pandemic. "Ukraine has something to be proud of in terms of countering COVID-19... From the first day of fighting COVID-19, our actions were smart and effective," the president added.

In particular, the President noted the effectiveness of tough quarantine.

Deficit of Ukraine's foreign trade in goods down to \$4.878 billion in 2020

The deficit of Ukraine's foreign trade in goods in 2020 decreased by 54.6% compared to 2019 and amounted to \$4.878 billion (in 2019 some \$10.746 billion), the State Statistics Service has reported.


In 2020, export of goods compared to 2019 decreased by 1.7% (by \$847 million), amounting to \$49.213 billion, import by 11% (by \$6.692 billion), to \$54.091 billion.

The coverage of imports by exports was 0.91 (in 2019 some 0.82).

The seasonally adjusted exports of goods in December 2020 compared to November increased by 3.3%, imports – by 3.7%. The seasonally adjusted foreign trade balance in December 2020 was negative and amounted to \$499 million. In November 2020, it was also negative at \$465 million.

United Arab Emirates and Ukraine sign memos and contracts worth \$3 billion


Ukraine and the United Arab Emirates have signed memorandums and contracts worth \$3 billion or more, the presidential press service said. "As part of the official visit of Ukrainian President Volodymyr Zelensky to the United Arab Emirates, the Ukrainian delegation signed a number of memorandums and contracts totaling \$3 billion or more," the press service said in the statement. In particular, memorandums of understanding were signed between the State Property Fund of Ukraine and the Mubadala investment company. They are aimed at deepening cooperation in the development of promising investment projects and the participation of the Emirate side in the program of privatization of state-owned property in Ukraine.

"At all international meetings, I urge to invest in Ukraine. Our state has enormous potential: geopolitical position, natural resources, people of knowledge. Right now is the time to understand this potential and create a strong economy," Zelensky said.


He said that attracting investment is the key to Ukraine's economic growth. "The signing of a memorandum with the Mubadala investment company of the government of Abu Dhabi on intentions to invest in Ukraine is a very important step in opening the way for major investments in Ukraine from Western Asia," Zelensky said.

In addition, the Ministry of Digital Transformation of Ukraine signed a memorandum with INTELMAX Management Consulting, which provides for cooperation on the creation of a platform for the exchange of intellectual property based on the Fantom blockchain, which will provide increased security and transparency. It is also planned to introduce blockchain technologies into government processes and services.

Ukraine wants Ukrainian business to have more access to European markets

Prime Minister of Ukraine Denys Shmyhal says that Ukraine wants Ukrainian business to have more access to European markets, and negotiations will allow increasing the volume of trade quotas.

"We are talking about the further liberalization of trade between Ukraine and the EU. This will help increase our mutual trade and further convergence of economies ... We want Ukrainian business to have more access to European markets, and hope that our negotiations will allow increasing the volume of quotas provided for our agreement with the EU," Shmyhal said at a joint briefing with Executive Vice President of the European Commission Valdis Dombrovskis in Brussels.

Shmyhal stressed that Ukraine intends to use 2021 for solid work, the result of which should be an actual approximation to EU standards.



European Union stresses importance of judicial reform in Ukraine

The European Union welcomes Ukraine's progress in reforms, but significant work still needs to be done in this regard, in particular, judicial reform, EU Commissioner for European Neighborhood Policy and Enlargement Negotiations Olivér Várhelyi said.

"A significant part of the meeting today was devoted to reforms and their implementation. We see that Ukrainian government continues to take a number of very important steps in all directions. Despite this, there is still a lot of work to be done. This is very welcome, but we need to see further progress. This includes, in particular, the need for judicial reform. We are ready to help, and we continue to help Ukraine in this regard," he said at a press conference after the seventh meeting of the EU-Ukraine Association Council in Brussels on Thursday, February 11.

Várhelyi said that the most important areas of reform for Ukraine are the establishment of the rule of law and judicial reform, the fight against corruption and economic reforms.



Ukraine raises annual e-limit of investments abroad for individuals from EUR 100,000 to EUR 200,000

The National Bank of Ukraine (NBU) has raised the e-limit of investments abroad for individuals from EUR 100,000 to EUR 200,000 per year, the press service of the regulator has said. The corresponding changes were approved by the decree of the NBU board of February 3, 2021 (No. 14), which was posted on the National Bank's website and comes into force on February 5.

66 The report specifies that the e-limit has been increased for investments abroad, placing funds on their own foreign accounts, transferring funds under a life insurance contract and providing loans to non-residents.

"This decision in the direction of currency liberalization will not have a significant impact on the functioning of the currency market of Ukraine, including taking into account the fact that individuals have been able to buy non-cash foreign currency for more than a year without any obligations and grounds," the press service said citing Deputy Governor of the NBU Yurii Heletii.

He noted that in 2020, individuals within the e-limit transferred about EUR274 million abroad, which is less than the average daily trading volume in the interbank foreign exchange market.

As reported, since December 18, 2019, the National Bank has increased the annual e-limit on individual foreign exchange transactions by individuals from EUR 50,000 to EUR 100,000 per year.

Nordic Environment Finance Corporation provided loans to 11 cities of Ukraine in 2020



The Nordic Environment Finance Corporation (NEFCO) last year provided 12 loans to 11 cities of Ukraine for a total amount of EUR 15.54 million and UAH 60.71 million, eight of which were allocated in the last days of the year, the Ministry of Finance has said on its website.

Kremenchuk (Poltava region) received the largest loans – a EUR 6 million 10-year loan at the rate of EURIBOR 6M

- + 6.25%, as well as a UAH 13 million five-year loan at 3%. It is followed by Rivne with EUR4.43 million for eight years at the rate of EURIBOR 6M + 5.85%.
- In addition, Lutsk and Sumy at the end of the year received EUR 1.6 million and EUR 1.5 million for 10 years at a rate of 6%, Horishni Plavni received EUR 0.512 million for 10 years at 3%, and Lubny (both in Poltava region) got EUR 1 million at 3%.

NEFCO provided another foreign currency loan to Mykolaiv in July last year – EUR0.5 million for seven years at 6%, while the remaining loans were in hryvnias for five years at a rate of 3%.

These projects provide a small amount of grant support and co-financing from the municipal authorities.



Odessa Filatov Institute for the first time in the world removes intraocular hemangioma

The Filatov Institute of Eye Diseases and Tissue Therapy of the National Academy of Medical Sciences of Ukraine (Odesa) for the first time in the world conducted a unique operation to remove a large intraocular hemangioma of the choroid.

According to a press release of the institute, the operation was performed at the end of 2020 on a 21-year-old patient due to the impossibility of using non-surgical methods of treatment because of the large tumor size (12.2 mm x 16.1 mm, bulging into the vitreous humor - 6 mm), which continued to grow.

"Understanding what the loss of an eye would mean for a young active girl, both from a cosmetic and psychological point of view, the doctors of the Filatov Institute offered the patient an operation," the press release said.

To reduce the risk of bleeding, the specialists of the institute used their unique development – the method of highfrequency welding of biological tissues in ophthalmology, developed jointly with the Paton Institute of Electric Welding of the National Academy of Sciences of Ukraine. They also developed the tools necessary for the interventions.

C The operation was carried out by one of the authors of the method, Doctor of Medical Sciences Mykola Umanets. During the operation, which lasted several hours, each dissected vessel was "welded" to prevent bleeding.



"When the patient came for a check-up a month later, the doctors were not only convinced that they had managed to save the eye, but also revealed the appearance of her "silhouette vision," which was not there before the operation," the press release said. At present, the institute's specialists are preparing publications for world-famous ophthalmological editions. The video filming made during the operation will allow presenting a unique achievement at the world conferences and congresses. Hemangioma is benign neoplasms that affect the blood vessels of a person in various parts of the body.

In the case of formation in the choroid of the eye, they do not threaten the patient's life, however, they are accompanied by a significant decrease in vision and can cause the development of serious complications, such as retinal detachment, hemorrhage into the eye cavity, increased intraocular pressure (glaucoma). Currently, there are a number of treatment methods for this pathology, aimed at stopping the growth and destruction of the tumor and are effective in the case of small formations.

The only attempt to surgically remove an intraocular hemangioma recorded by the world ophthalmological community is an operation performed in 2019 by Italian ophthalmologist Barbara Parolini. In that case, the tumor was small. In the case of a large lesion and/ or its unsuccessful location, surgical removal of intraocular hemangiomas is not performed due to a very high risk of bleeding and a lack of effective methods to stop it. Most often, the only way to solve the problem is to remove the eye.



Ukrainian energy minister estimates compensation to 'green' generation until 2029 at \$10-20 bln

An overstated tariff for energy from renewable sources (RES) in comparison with the market rate leads to significant and problematic payments to investors for Ukraine, which are estimated at \$ 10-20 billion until 2029, acting Energy Minister Yuriy Vitrenko has said.

"If to look at the difference between the feed-in tariff and the market price, at least now, and multiply this by conservative estimates of production from renewable sources and multiply this by the term of the feed-in tariff – until 2029, then the amount of compensation from the state budget to investors in green energy will be from \$ 10 billion to \$ 20 billion," he said while discussing the economic strategy until 2030.

Vitrenko noted that the feed-in tariff is several times higher than the market price.

66 *"For a developing country like Ukraine, \$ 10-20 billion is a significant amount, which is a problem," he stressed.*

The minister also criticized the current system of payments through the energy system operator Ukrenergo, which has no interest in paying for renewable energy sources, since their uneven generation brings it additional problems. According to Vitrenko, such payments should be made through the state budget as a public good in the form of clean energy.



Intelmax from Abu Dhabi plans to open office in Ukraine

The Ministry of Digital Transformation of Ukraine and Intelmax have signed documents for opening a representative office of Intelmax Management Consulting (Abu Dhabi, the UAE) in Ukraine and cooperation on creating a platform for intellectual property exchange.

"Intelmax Management Consulting plans to open a representative office in Ukraine. A memorandum was signed between the Ministry of Digital Development and Intelmax during the visit of the president of Ukraine to the United Arab Emirates," Deputy Prime Minister, Minister of Digital Transformation of Ukraine Mykhailo Fedorov wrote on Facebook.

According to him, the document also provides for the introduction of blockchain technologies into government processes and services.

"Ukraine is moving forward, making a digital revolution in all government institutions. Therefore, the implementation of blockchain-based solutions is an important stage in development," Intelmax said. It notes that within the framework of cooperation, the parties will also consider the possibility of introducing a national Ukrainian stablecoin based on the Fantom blockchain with targeting and distribution of social and business benefits.



British company to open 11-th workspace in Ukrainian capital

UK-based IWG Plc, a provider of flexible office solutions, will open a new Regus workspace in Kyiv, expanding its network in Ukraine to 11 locations.

Director of IWG in Ukraine Yulia Lytvynenko told Interfax-Ukraine that the new Regus will be opened in the Volodymyrsky business center on Poshtova Square in the middle of March.

"On three floors we are preparing super-comfortable, modern flexible offices. On the basement floor there will be a business club and a negotiation area, and offices on two floors higher. The highlight, surely, will be beautiful views of the Dnipro [River] on the one hand and the park on the other. The design of the location will be made in a modern style with warm colors," Lytvynenko said.



According to her, the opening of the third Regus in Podil is due to the high interest of business in this area, especially from foreign residents of IWG. The expert evaluates positively the activity of Kyiv's office real estate market.

"During the first wave of lockdown, we had a small outflow of residents, primarily startups that did not calculate their strength. But since the middle of last year, we have seen an influx of representatives of large corporate businesses who appreciated the advantages of hybrid office models," Lytvynenko said. Now the loading of IWG spaces in Ukraine is at the level of 78%, there are several large agreements to be signed.

European Investment Bank to provide Ukraine with EUR 50 mln for vaccination

The European Investment Bank will provide Ukraine with EUR 50 million for vaccination against COVID-19, Deputy Health Minister Ihor Ivaschenko said during a press briefing in Kyiv on Monday.

"Last week, the Cabinet of Ministers approved a president's order authorizing Health Minister Maksym Stepanov to sign a letter amending the financial agreement between Ukraine and the EIB," he said.

"The government has asked the EIB to redistribute part of the funds and channel them to the vaccination of the population in Ukraine. The Cabinet of Ministers has received confirmation of the provision of EUR 50 million, which will be used for the purchase of vaccines, equipment for the refrigerating chain, as well as logistics. Relevant amendments to the agreement will be signed in the near future," the deputy minister said.

Market for new commercial vehicles in Ukraine grows by 6% in Jan

Primary registrations of new commercial vehicles in Ukraine (including heavy trucks) in January 2021 grew by 6% compared to the same month in 2020, to 901 units, despite sales restrictions due to a two-week lockdown, according to the Ukrautoprom association.

At the same time, as in the previous year, Renault vehicles were leaders with sales growth of almost 36%, to 202 units and a market share of 22% (versus 17.5% in January 2020).

Peugeot was in the second position in the ranking (climbing from the third in January 2020) with registration of 97 vehicles (8% more), and Fiat was third (second a year earlier), which registrations fell by 36%, to 90 units.

Belarusian MAZ trucks increased sales by 22% compared to January last year, to 89 units, and this allowed them to improve their position in the ranking from fifth to fourth, and Ford was also in the top five of the month, with sales January 2020 amounting to 84 units.

According to the association's statistics, sales of Chinese HOWO trucks rose significantly in January to 40 units compared to eight, and a significant drop was demonstrated by MAN trucks – 7 units versus 51 a year earlier.

In January, Russian brands were registered in Ukraine – GAZ (25 units), UAZ (8 units), KAMAZ (7 units), while Ukrainian KrAZs were not on the list.

The association also cites statistics on bus sales (including minibuses) in Ukraine in January: they grew by 7.1%, to 181 units.

The leader in this segment, as in January last year, was Citroen buses with a 3% increase in sales, to 67 units. Ukrainian Etalon buses with registration of 30 vehicles versus 21 units climbed to the second position in January 2020. At the same time, Ataman buses (manufactured by the Cherkasy Bus Plant), which ranked second a year earlier, dropped to the seventh line of the rating, with registrations falling by 67%, to 8 units.

The initial registrations of Belarusian MAZ buses increased 3.7 times, to 22 units, which allowed the brand to enter the top three, and ZAZ buses with 18 cars (three times more) were fourth.

Volkswagen was also in the top five leaders of the bus market (10 units), which in January 2020 did not register its buses.

Ukravtodor and Turkey's Dogus sign contract for building new bridge

The State Agency of Automobile Roads of Ukraine (Ukravtodor) has signed an agreement for the construction of a new bridge in Kremenchuk (Poltava region) for UAH 11.249 billion with the Turkish company Dogus Insaat Ve Ticaret. On the part of Ukravtodor, the contract was signed by the head of the road service in Poltava region, Ivan Krapovnytsky, from Dogus Insaat Ve Ticaret – executive director Tolga Akkas.

Ukravtodor noted that the new bridge will improve the optimization of logistics routes in the center of Ukraine by reducing travel times for road transport. This will be achieved by increasing the speed limit for trucks from 36.8-53.3 km/h to 72.9 km/h, buses from 35.7-53.4 km/h to 71.1 km/h, passenger cars from 39.6-55.3 km/h to 81.5 km/h.

"All plots that fall under the construction zone will be bought for state funds. If these are private plots where people live, or some other private plots, they will be bought out, transferred to the state ownership, and people will receive monetary compensation for this," Krapovnytsky said.



Windrose to launch regular cargo flight between Kiev and Hong Kong

Windrose (Kyiv) from February 14, 2021 will open a regular cargo flight between Kyiv and Hong Kong. According to the company's press service on Tuesday, from February 14 to December 27, 2021, cargo flights on the Kyiv-Hong Kong-Kyiv route will be performed on Sundays from Kyiv to Hong Kong and on Mondays back.

"Windrose Airlines hopes that the opening of this program will help all market participants to accelerate the delivery of cargo both from Hong Kong to Kyiv and subsequently from Kyiv to Hong Kong," the company said.

The flights will be operated by Airbus A330-200 P2F aircraft, which has been modified for cargo transportation.

As reported, in November 2020, Windrose signed a wet leasing contract for Airbus A330 aircraft to perform cargo flights from Kyiv to New York and Hong Kong.



Export of grain from Ukraine in 2020/2021 MY to be 45.4 mln tonnes – forecast

The Ministry of Economy of Ukraine in the 2020/2021 marketing year (MY) forecasts a decline in grain exports by 20.5% compared to the previous MY, to 45.4 million tonnes.

According to the forecast balance released by the ministry, in particular, wheat exports will decline by 14.6%, to 17.5 million tonnes, corn by 22.4%, to 23.5 million tonnes and barley by 23.8%, to 3.82 million tonnes.

According to the ministry, the total production of grains and legumes in this MY is expected at 65.5 million tonnes.

Ukrainian KSG Agro raises export of agricultural products to Asia and Africa

KSG Agro agricultural holding in 2020 increased export of agricultural products to African and Asian markets by 46%, to 7,770 tonnes, the holding's press service has said.

"Last year, we expanded our presence in export African and Asian markets. In the context of the quarantine crisis, the issue of diversifying supplies and expanding the range of products supplied is especially acute," Serhiy Kasyanov, the head of the board of directors of KSG Agro, said.



According to the agricultural holding, in 2020, the export of wheat flour to Libya increased by 3.6 times compared to 2019, to 3,000 tonnes. It is clarified that KSG Agro exported 172 tonnes of sugar to Libya, 4,000 tonnes of corn to Malaysia, 600 tonnes of barley to Oman.

Ukraine plans to launch own satellite with American SpaceX rocket

Ukraine has preliminarily selected the American company SpaceX of Elon Musk to launch the Sich 2-30 (2-1) remote sensing satellite in December this year and is currently in technical negotiations with it, Deputy Prime Minister, Minister for Strategic Industries of Ukraine Oleh Urusky has said.

"We really have a window to launch the device in December with the help of a foreign operator – in this case SpaceX, with which we are now cooperating in terms of the compatibility of the device with launch vehicles," the deputy prime minister said in an interview on Pershy Dilovy TV channel.



Urusky clarified that work with SpaceX is going on intensively and in the near future it will be clear whether it is fundamentally possible to combine the Ukrainian satellite with a SpaceX launch vehicle.

The official noted that today the satellite is practically ready.

"It requires final analysis and operational checks of technical readiness for launch," he explained.

Urusky added that he personally visited Pivdenmash in Dnipro, where he checked the real state of the spacecraft.

He recalled that the last time Ukraine launched a remote sensing satellite was 10 years ago, so the launch of the new satellite will be an outstanding event.

As reported, President of Ukraine Volodymyr Zelensky earlier this year, commenting on Musk's statement about communication with the family of Serhiy Korolyov, invited the American businessman and founder of the space company SpaceX to visit the Korolyov Museum of Cosmonautics in Zhytomyr.
