

### Ukraine is not planning to halt air traffic



Ukraine is not planning to halt air traffic and is working to prevent risks for airline, the Ukrainian authorities said. Reports about Ukraine closing its airspace are not true, the Ukrainian Ministry of Infrastructure said in a statement. The closure of airspace is Ukraine's sovereign right; no such decision has been made, the ministry said.

"Today [on February 13], there was a working meeting in the Ministry of Infrastructure. Senior officials of the Office of the President of Ukraine, the State Aviation Service of Ukraine, state-owned enterprise UkSATSE, Boryspil International Airport and Ukrainian airlines attended the meeting dedicated to the situation on the air transport services market. A solution preventing any further exacerbation of the situation was elaborated at the meeting," the ministry said.

A majority of airlines are continuing operations without any restrictions, it said.

"Some carriers face difficulties associated with fluctuations on insurance markets. The state, for its part, is ready to support air carriers and is planning to provide additional financial guarantees to support the aviation market," it said.

### Ukrainian government approves free trade agreement with Turkey

The Cabinet of Ministers approved the draft Free Trade Agreement (FTA) with Turkey at a government meeting. According to First Deputy Prime Minister, Minister of Economy Yulia Svyrydenko, the agreement will bring an additional 2% of GDP annually.

**"The basis of the agreement is the zeroing of duties by Turkey for 10,337 commodity items.** This is 95% of the total number of goods. Another 1,348 commodity items will be subject to tariff quotas or duty reduction," she said, presenting the draft FTA Agreement with Turkey at the government meeting.



Currently, Ukraine exports 1,100 commodity items to Turkey, since Turkey has one of the highest levels of customs protection in the world, she said. At the same time, the level of Ukrainian customs duties is one of the lowest.

"In recent years, we have begun to observe that Ukrainian duties have generally ceased to be a barrier to Turkish goods, while Turkish duties for our goods have been an impenetrable wall for entering their market," Svyrydenko said.

According to her, Ukraine reserves the right to apply a duty on the export of scrap metal.

#### **US President calls on all US citizens to leave Ukraine**

US President Joe Biden called on all Americans who remain in Ukraine to leave the country.

"American citizens should leave now," Biden said in an interview with NBC News.

"It's not like we're dealing with a terrorist organization. We're dealing with one of the largest armies in the world," he said.

"It's a very different situation, and things could go crazy quickly," Biden said.

However, he noted that Russian President Vladimir Putin "is smart enough not to, in fact, do anything that would negatively impact on American citizens."

#### France provides EUR 1.2 bln to Ukraine

EU macro-financial assistance in the amount of EUR 1.2 billion, in providing which France has taken an active part, will be used to stabilize the Ukrainian economy, President of Ukraine Volodymyr Zelensky has said following a meeting with French President Emmanuel Macron.

"Economic support is very important, and we really appreciate such a step of solidarity with other states, a powerful step on the part of Emmanuel, on the part of France – the allocation of EUR 1.2 billion in macro-financial assistance to Ukraine. This will really help us stabilize our economy. We are already doing well, but this is a powerful step for the economic sustainability of Ukraine," Zelensky said at a joint press conference with Macron.



### EU council approves EUR 1.2 bln aid to Ukraine

The Council of the European Union approved on Friday the decision of the European Commission to provide additional macro-financial assistance worth EUR 1.2 billion to Ukraine.

"The current geopolitical tensions are having a severe economic impact on Ukraine. Member states are ready to provide EUR 1.2 billion macro-financial assistance. We decided to support the Commission's proposal today, so that the financial help can reach Ukraine without delay," President of the EU Council, French Minister for Economic Affairs, Finance and Recovery Bruno Le Maire said.

The decision will come into force after approval by the European Parliament, which should happen in the near future. The emergency macro-financial assistance is set to have a duration of 12 months and it would consist of two disbursements. The disbursement of the second tranche would be linked to the continuous satisfactory implementation of both an IMF programme and the policy measures agreed in the Memorandum of Understanding.

"Persistent security threats have triggered a substantial outflow of capital. Against the backdrop of the loss of access to international capital markets due to the heightened geopolitical uncertainty and its impact on the economic situation in Ukraine," the EU Council press service said, justifying the urgency of providing additional assistance.

### I-Dolina will cooperate with KNUCA and the State Fund for Youth Housing

On January 31, this year, Kyiv National University of Construction and Architecture hosted a ceremony of signing a landmark memorandum of cooperation between the International Technology Transfer Association (ITTA) headed by Artem Honcharenko, Kyiv National University of Construction and Architecture led by rector Petro Kulikov, and the State Fund for Youth Housing run by Serhiy Komnatnyi and I-Dolina headed by Chairman of the Board Alexander Teplyuk.

Artem Honcharenko, President of the International Technology Transfer Association (ITTA), drew attention to the possibility of using world experience in government programs to support and attract foreign investors, providing them with favorable conditions. Experts of the association will help develop these areas and increase the number of attracted investments..

Projects are designed to provide both Ukraine and other countries with modern personnel in construction and architecture.

### Minister of Health: Lockdown not provided in Ukraine

Minister of Health of Ukraine Viktor Liashko said that a lockdown due to the omicron coronavirus strain is not envisaged in Ukraine, the press service of the Ministry of Health reported. "There will be no lockdown. We work in an adaptive quarantine that provides for a 'red zone," the press service of the Ministry of Health quoted Liashko as saying.

It is reported that at present there are enough vaccines against coronavirus in the country, so it is inappropriate to talk about tightening quarantine measures.

At the same time, the Ministry of Health notes that as soon as the vaccination rate reaches 70%, adaptive quarantine will also end.

### Number of branches of Ukrainian banks goes down by 6.3%

Ukrainian banks in 2021 reduced the number of structural units by 6.3%, or by 449 branches, to 6,685.

According to data on the website of the National Bank of Ukraine (NBU), in 2021 Oschadbank closed 235 branches (reducing their number to 1,602), PrivatBank – 220 (to 1,497), UkrSibbank – 21 (to 251), Alfa Bank – 17 (to 201), Pivdenny Bank – 10 (to 87), Ukreximbank – 9 (to 53), Ukrgasbank – 8 (268), PIB – 7 (19), Sberbank – 5 (85), Raiffeisen Bank Aval – 4 (to 392).


At the same time, in 2020 banks opened 84 branches, including Accordbank – 28 branches, expanding its regional network to 107 branches, FUIB – 24 (up to 248), Crystalbank – 12 (up to 36), A-Bank – 7 (up to 239), Alliance Bank, CIB and Ukrbudinvestbank – 5 each (up to 30, 43 and 53, respectively).

According to the data of the National Bank, as of January 1, 2022 Oschadbank remains the leader in terms of the number of branches (1,602), the second place is occupied by PrivatBank (1,497), the third is Raiffeisen Bank Aval (392), the fourth is Ukrgasbank (268) and the fifth – UkrSibbank (251).

As in the first half of the year, Prominvestbank (PIB), Albank, Credit Europe and Familny banks, BTA Bank, ING Bank Ukraine, Citibank, Trust-Capital Bank, the Ukrainian Bank for Reconstruction and Development (UBRD), CreditWest Bank, Deutsche Bank DBU, SEB Corporate Bank, Alpari Bank, Avangard Bank and Portal Bank, according to the regulator's data, operate with one open branch.

# Ukraine International Airlines operates flights without changes

Ukraine International Airlines (UIA) will continue operating flights according to the existing schedule, the company's press service reported on February 14. "Ukraine International Airlines will continue to operate flights according to the existing schedule, operating 16 medium-haul aircraft without any changes in the schedule. In particular, today's evening flights and tomorrow's morning flights are operated without changes," the company said in a statement.

UIA said the preservation of operational work was made possible by a constructive dialogue between UIA's business partners, as well as cooperation with the Government of Ukraine.

"Currently, tickets for flights of UIA and partners are on sale on the official website of the airline. The airline will continue to regularly report any possible changes in its operations," the airline said.



## Subdivision of Avtostrada group completes drilling work on interchange at Darnytsky bridge

The bridge-building subdivision of Avtostrada group of companies continues work on the construction of the left-bank interchange of the Darnytsky Bridge in Kyiv; at present, the installation of bored piles has been completed at the facility and preparatory work has begun to install ramp structures.



The press service of the group reported on Tuesday that a total of 55 piles with a diameter of 1.5 meters were drilled and concreted. About 2,500 cubic meters of monolithic concrete was used. To carry out these works, powerful equipment was involved – Bauer BG 45 and BG 36drilling rigs.

In addition, a number of other works have been carried out. So, at object No. 8L (exit towards Bazhana Avenue), 12 grillages and 23 blocks of bulkhead were installed. Each such block weighs up to 14-15 tonnes. At present, joint grouting work is underway, and in the coming days another 80 blocks will be installed. About 1,200 cubic meters of monolithic concrete was used during the installation of the structure.

#### 8 centers for growing seedlings to be built in Ukraine

Eight centers for growing seedlings with a closed root system will be built in Ukraine in 2022 using the technologies of the Swedish company BCC, according to the website of the State Forest Resources Agency of Ukraine.

**"**During this year, we plan to build eight seed breeding factories, which will significantly increase the capacity for growing planting material. This will allow us to successfully implement the Green Country presidential program (President of Ukraine Volodymyr Zelensky) and plant one billion trees in 3 years," the agency said.

According to the plans for the construction of forest planting complexes published by the department, plants for growing seedlings will be located in Volyn, Zhytomyr, Zakarpattia, Ivano-Frankivsk, Kyiv, Kirovohrad, Sumy and Chernihiv regions.





# FTA with Turkey may make some types of Ukrainian agricultural products uncompetitive in Ukraine and in foreign markets

A free trade agreement with Turkey may make some types of Ukrainian agricultural products uncompetitive in Ukraine and in foreign markets, since Turkish food products have already taken a strong position around the world, and similar Ukrainian products may not find markets there.

Head of the Ukrainian Agricultural Export Association (UAEA) Dmytro Kroshka told Interfax-Ukraine on Monday about the impact of the FTA agreement with Turkey signed on February 3 on the export of Ukrainian agricultural products.

"Competition between Ukraine and Turkey is most visible on the markets of third countries. We have already determined that Turkish tomato on the Ukrainian market will be cheaper than domestic. Our producer understands that if he cannot make money on the Ukrainian market, he will seek sales in Europe or somewhere else, where it turns out that Turkey is exactly the same in those markets. And sooner or later, a manufacturer that cannot reorient itself will have to reduce production or abandon it, this is very likely," the head of the association said.

He said that the key risk for the Ukrainian agribusiness from the zeroing of customs duties is the export orientation of Turkish producers, supported and controlled by the state.

"In Turkey, there is a huge infrastructural and financial support for exporters. The state establishes KPI there, and a manufacturer is supported, whose products are not just produced, but exported. And for a manufacturer to export, its products must meet the quality requirements that the market requires, and not only increase the volume. The effect of Turkish policy has become actively noticeable to us in recent years, when the active expansion of Ukrainian products to world markets began," Kroshka said.

The head of the UAAE said that Ukrainian producers of apples, nuts and other products of the fruit and nut group will definitely benefit from the actions of the FTA, which Turkey will be able to re-export to the countries of the Middle East and Africa, taking advantage of its favorable geographical location. However, this is guaranteed to have a negative impact on vegetable and egg producers.

"We just need to look at the news about the FTA between Ukraine and Turkey as news that we will sell more there and the trade turnover will certainly increase. But at the same time, I believe that this agreement will reveal a wave of internal Ukrainian economic problems in agriculture, which are linked to the production of agricultural goods common with key Turkish products," the expert said.

#### Largest sugar producer in Ukraine to invest \$15 mln in new silo construction

Agroholding Astarta, the largest sugar producer in Ukraine, is investing \$15 million in the construction of a new silo in the city of Chernihiv. The decision of the board of directors of the group of companies was published on the Warsaw Stock Exchange (WSE) on Wednesday evening.

According to Astarta, the construction of this facility will will further strengthen the company's network of seven grain and oilseeds handling facilities and expand its reach to Chernihiv region.

The total capacity of simultaneous storage of grain and oilseeds will be 70,000 tonnes. Commissioning of the first stage of the silo with a capacity of 58,000 tonnes is scheduled for July 2022.

#### China, Egypt, Turkey are main importers of Ukrainian grain in 2021

Ukraine's revenue from export of grain crops in 2021 amounted to \$12.3 billion, the largest trading partners were China, which imported \$2.55 billion, as well as Egypt (\$1.39 billion) and Turkey (\$0.92 billion), the Institute of Agrarian Economics (IAE) reported on its website on Thursday.

"2021 was characterized by the further strengthening of the position of China, which in 2020 for the first time took the top among 10 largest importers of Ukrainian grain. In four years, starting from 2018, this country has increased its grain purchases from Ukraine almost five times, to \$2.55 billion. At the same time,

#### **China's share in the value of domestic grain exports** increased from 19.7% in 2020 to 20.7% in 2021," the IAE said, citing expert Bohdan Dukhnitsky.

According to the IAE, last year Egypt increased imports of Ukrainian grains by 24%, from \$1.12 billion to \$1.37 billion, but its share of their total exports decreased from 11.9% to 11.2%.

"Turkey, which in 2020 ranked only sixth in the top 10, moved up to the third spot last year, increasing the value of purchases of Ukrainian grain to \$0.92 billion. In addition, in 2021, there were changes in the top 10 largest buyers of grain from Ukraine: Iran and Pakistan pushed South Korea and Bangladesh out of the top 10," the expert said in the IAE report.

Other major grain importers from Ukraine were Indonesia with \$750 million, Spain with \$645 million, the Netherlands with \$552 million, Iran with \$533 million, Pakistan with \$355 million, Libya with \$342 million and Tunisia with \$306 million.
